Dear Option Holder

OPTIONS (ASX : EMRO) TO ACQUIRE EMERALD OIL & GAS NL SHARES AT 5 CENTS PER SHARE EXPIRE ON 31 AUGUST 2012

We are writing to you as a registered holder of 31 AUGUST 2012 options in EMERALD OIL & GAS NL ("the Company") to remind you that the options will expire at 5:00pm (WST) on 31 AUGUST 2012.

Your option holding may be exercised in <u>whole or in part</u> by payment of 5 cents for each option by no later than 31 AUGUST 2012. If payment is not received by 5:00pm (WST) on 31 AUGUST 2012 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 31 AUGUST 2012.
- b) Sell your options. Quotation of the options will cease at the close of trading on 24 AUGUST 2012.
- c) Do nothing (ie, allow your options to expire). If you do not exercise or sell your options they will expire on 31 AUGUST 2012 and your right to subscribe for ordinary shares in EMERALD OIL & GAS NL at 5 cents per share will lapse.

There is no obligation on option holders to exercise their options. However, under paragraph 6.1 of Appendix 6A of the Australian Stock Exchange (ASX) Listing Rules, the Company is required to advise option holders of the information contained in this notice.
