Emerald Resources NL (ASX:EMR) ('Emerald') is pleased to announce that it has closed its \$3 million Share Purchase Plan (SPP Offer) which it announced on 30 October 2018.

The SPP Offer was in addition to a successful A\$27 million fully subscribed placement strongly supported by existing and new institutional shareholders (Placement).

The Placement (together with the SPP Offer) provides funding to be used towards:

- commence development activities at the Okvau Project;
- regional exploration program on Emerald's 1,442km² Cambodian exploration footprint;
- repayment of unsecured loans; and
- ongoing working capital requirements and costs of the Placement.

The SPP Offer was open to all eligible shareholders as at 7.00pm (Sydney time) on the record date of 29 October 2018, and whose registered address was in Australia or New Zealand (Eligible Holders). Eligible Holders were invited to invest in the SPP up to a maximum of A\$15,000 per shareholder at an issue price of 3.0 cents per share, subject to an overall cap of A\$3 million (New Shares).

The Company received valid applications for 31,000,000 New Shares from Eligible Holders, raising \$930,000 before costs. An Appendix 3B reflecting the securities issued as outlined above is attached to this announcement.
